評議會主席、各位評議員:

大家好!感謝大家的信任與支持,使到我能夠回到學生會,繼續服務同學。

學生會,是我出身的地方。一位前會長跟我說:「回到學生會,就像返回我出生的醫院一樣。如果有人提出 要取締學生會,我必定會站出來反對。」沒錯,跟他一樣,學生會是很多人成長的地方,他們對學生會有著

獨特的感情。也因為這份濃厚的感情,我毅然決定參選學生會,希望帶領學生會走出陰暗,步入另一個光榮 百載。

我今天演說的主題是:「放下成見,團結一致」。過去兩年,我在學生會見證了不少風風雨雨,目睹從幹事 會、屬會至各評議員之間的紛爭,感到十分痛心和擔憂。讓各屬會共謀會員福祉的評議會,淪為鬥過你死我 活的羅馬競技場。相互抨擊的文化,以及屬會之間的鴻溝更是年年俱增,長久下去對學生會發展極不健康, 無助促進會員福祉,我們是時候要「放下成見,團結一致」了。

德蘭修女有一句名言:「和平來自於每一個微笑。」我憧憬的港大同學,會主動踏出第一步,給予其他人一 個真誠的微笑。他們之間沒有互相猜忌,沒有背後中傷,沒有惡意批評,只有真摯的友情。

查里卓別靈曾謂:「我們要把幸福建築在別人的幸福上,而不是建築在別人的痛苦上。我們不要互相仇恨, 互相鄙視。這個世界上有足夠的地方讓人生活,大地是富饒的,是可以使每一個人都豐衣足食的。」世界上 有很多國家基於利益爭鬥,互相仇恨,互相鄙視,導致戰火連連,最大的受害者是平民百姓。學生會應借鑑 警惕--僵持不下,拒絕合作,只會使到同學的利益受損。其實,學生會的各個院會、舍堂學生會、三聯會, 都擔當著同學們在大學生活中全人發展的重要元素,三種學會之間並不存在競爭。服務同學,從來不是零和 遊戲,而是互利共生。我憧憬的學生會,屬會不只是考慮自身的利益,而且會思考怎樣達到雙贏的局面。

每一個屬會成立的宗旨都是以同學的利益出發,所以,學生會各屬會是應該團結、合作、配合的,但令我痛 心的是,學生會發展到近百年之際卻迷失了方向。仇恨蒙蔽人的雙眼,使人迷失,步入窘局,一莊傳一莊的 不滿築起大家仇恨的壁壘。我憧憬的學生會,是一個人人不築牆,而築橋的地方。

另外,我必須要向老鬼們表達謝意,但我希望,每一支莊都能獨立地決定發展方向,過往各屬會之間的恩怨 能一筆勾消。無論從感性或理性層面思考,我都實在想不出延續過去紛爭的理由。我憧憬的學生會,是一個 充滿人性的地方;是所有人懷著共同理想的地方。

在此,我許下三不承諾。第一,我必須強調自己過去兩年不論在三聯會、院會或舍堂學生會都是活躍份子, 當選會長後,所有屬會都是我的屬會,我有責任保障各屬會的長遠發展,以繼續服務同學,我「不」會偏袒 任何一個屬會,讓少數團體的利益凌駕整體同學的福祉;第二,我絕「不」容許有人為滿足權力慾望,煽風 點火,干預學生會的運作;第三,即使遭遇到來自學生會內、校方或甚至校外的壓力,都絕「不」畏縮,貫 徹大公無私、敢言、公義的原則。

最後,我要告訴各位,只要大家肯「放下成見,團結一致」,學生會的嚴冬將快成過去,大家亦是時候要迎 接春暖花開之時。我的演說就此作畢,多謝各位!
