#### Section B

#### 1. To receive the Council Chairman's address

CC delivered his Council Chairman's address to the Council.

Chairman, councilors and my fellows:

First of all, I would like to express my thanks to councilors for giving me an opportunity to serve the Union for one more year.

Session 2010, as I regard, is an 'unprecedented' year. Without popularly elected Union Executives, the Union Council, as the highest standing authority, inevitably took up the responsibility of formulating the policy and deciding over Union affairs. The Union Council, unfortunately, without the Union Executives to act as a bridge connecting various sub-organizations, became a 'battleground' for different sub-organization to solve conflicts and compete for their respective best interests. Some past councilors or Union members describe Session 2010 as 'Dark Era', terrible time, frustrating, far from expectation, etc. Nevertheless, I believe the last year's practice was just a natural outcome under the extraordinary circumstances. What is now important to Council Session 2011 is looking ahead through predecessor's lessons.

This year, with a united executive cabinet, I am confident that they will spare no effort to formulate policies and lead the whole Union. The Union Council, at the same time, should perform to its best to supervise the cabinet and all Union sub-organizations. In reality, however, except the executive cabinet, campus media and Popularly Elected Union Councilors, all of the remaining councilors are actually elected via respective sub-organizations' electors and designated mechanisms. As a sub-organization representative, raising

opinions in own party views shall never be questioned. Nonetheless, councilors shall not be bound by their own stances and need to take the overall benefits of the Union into account. Only if councilors fulfill the 'dual responsibilities' can the Union Council become a meaningful and hopeful place to discuss Union matters.

This year, the Union Council, with the presence of Union Executives, can focus more on Council and constitutional matters, rather than mere administrative works, such as resource allocation and orientation arrangement. As the Council Chairman sitting for two consecutive Sessions, I would put my emphasis on the most challenging and exciting task in the Union, which is Union Council restructuring reform. Despite the changes of University structure and increase of Union sub-organizations in recent decades, the Council composition still remains unchanged and is somehow outmoded to be a common platform for sub-organizations to collectively strive for benefits. Personally, I do not have any particular direction or guideline on Council restructuring. The future of the project shall not depend on my preferences, but councilors' aims and passion. The whole restructuring proposal is doomed to failure if councilors fail to balance interests amongst sub-organizations and make suitable compromises. Based on my initial observation I have much expectation on councilors in Session 2011 as all of you have shown us your enthusiasm and adequate preparations in the restructuring project. I have been disappointed several times in prior restructuring reforms but I am sure Council Session 2011 will not let me down.

With the involvement of councilors and Union members in Council restructuring, I can see a bright path in front of us that a more democratic and representative Union Council is awaiting us in Session 2012. Finally, again, I would like to thanks for Council's support and wish all you a great success in the coming Council Session.

- ♦ AS added the rapid change of chairmanship of a Council Committee was not healthy to the development of that Committee. FS(a) '10 and IVP agreed with AS, and further pointed out GS(a) '10 shall vacate the chairmanship of Administration Committee earlier.
- ♦ IVP asked how much effort GS(a)'10 put in the Information Day 2010. GS(a) '10 replied he went to final destination of the fixed route of Information Day 2010, and did the relevant observation.
- → GS (a)'10 clarified he never denied the importance of administration work after the adoption of Orientation Regulation.
- ♦ RCLHR '10 clarified that all members of Administration Committee of Session 2010, not only GS(a) '10 himself, shall be responsible for the Information Day 2010.
- ♦ STHR '10 described the Information Day 2010 was in chaos, and stressed that it was unfair to only criticize GS(a) '10 himself for his inappropriate arrangement.
- CAP looked for the cooperation among different parties in the future.

- ♦ IVP reported the chaotic situation of the previous election (e.g. one elector was given five ballots in the election of Undergraduate Student Membership to the Boards of Faculties at one time.)
  GS(a) '10 acknowledged the error and conducted a short briefing for that Election Officer again.
- ♦ GS(a) '10 was doubtful if a briefing session for Election Officers had to be held, provided that Election Officer Guide was delivered to the Election Officers.
- ♦ ASR commented the arrangement of polling station schedule could be improved.

  - After the General Polling, the definition of Academic Society shall be defined in Faculty Society Constitution, but in the past version, because of united definition on Academic Society, the Council By-laws gave some restrictions, criteria and procedures on formation of Academic Society.
  - The By-laws amendment shall be made as early as possible so that Faculty Society and Academic Society can amend their constitutions, following the direction and policy of the Union and Faculty Society.
  - The discussion might the By-laws amendments involve whether there would be any common standards or criteria for Academic Society; whether there would be any regulations imposed over Faculty Society when handling Academic Society affiliation application, etc.
  - Under the new curriculum, students would be required to take more courses in other Faculties. As a result, Academic Society, compared to the current curriculum, could have larger exposure to students from other Faculties which it was not affiliated to. The more common-core courses opened, the more the Faculty would be affected.
  - → Faculty Society shall carefully formulate its policy on the extent of Academic Society's recruitment
    of members from other Faculties.
