- HS, unlike CC and PP who could continue to hold the office without a vote of confidence, still needed a vote of confidence.

#### 2. To discuss the promotion and use of Union Song

- P said that the Latin version of school song of HKU had not been used nowadays; therefore he looked forward to a widespread promotion of the Union Song in order to build a sense of unity within the Union.
- P hoped that the Union Song could be implemented in the Internal Regulation and finally in the Constitution.
- ENSR, as quoted from ENS, questioned how the Union Song could be promoted. It seemed 'odd' if the promotion would be suddenly launched.
- P promised that there would not be a compulsory need for all Union sub-organizations to publicize the Union Song; but there would be a series of measures, including a light version of the song sung by Union Choir for the use of all Union sub-organizations. There would also be promotion for freshmen on Induction Day for freshmen.
- P pleaded for everyone to fully support the promotion campaign. AS said the proposed motions were the first step.
- P expressed his thankfulness to CTV for producing a video of the Union Song.
- SKYLHR asked how the Union could guarantee the promotion of Union Song. P replied that there would be a great flexibility to how the Union Song could be promoted. He reassured once again it shall not be compulsory to promote.
- EDSR asked when the light version of Union Song would be ready for distribution. P said that the MP3 file of Union Song would be recorded at the end of June 2011.
- P wished using the Union Song to bond all Union sub-organizations so that they would not feel apart from each other.
- P requested the above motions to be included in the Important Motions in the Council Handbook.

#### 3. To discuss the progress of Union Building relocation and the development of centennial campus

- IVP introduced the progress of the Union Building reconstruction and the new facilities.
- IVP promised that all tendering process would be made fair and open, and the biggest concern for determining successful applicants would be for the students.
- IVP confirmed that in the meantime CMs or ECMs could only be held in other venues until mid-October 2011, suggesting the University Council Chamber.
- On the University's Open Day there would be an opening ceremony of the Union Building.
- LHTHR raised the concern over the footbridge across Pokfulam Road.
- SKYLHR asked where the entrances of the Union Building would be during the Information Day, and how SKYLH members could go in and out. IVP replied that the entrance of G/F (the front door of SKLH) would be altered a bit; but SKYLH members could still have adequate access to their hall. When the entrances

would be cut off from access shall be answered from Estates Office of the University.

- SKYLHR requested IVP to send the presentation slides to all Councilors.

#### 4. To discuss universities affairs

- UAS1 briefly highlighted the survey done in previous month in the Report on Locker Removal.
- WLHR and PS questioned whether rain could splash against lockers in the proposed area.
- UAS1 believed that the major compromise was that chairs and tables would benefit students.
- LHHR hoped the tables and chairs would benefit students, and it would not destroy the beauty of the University with too many chairs and tables.
- SSR thought that umbrellas outside SS's room were weird; whereas WLHR said that umbrellas were good, especially in summer.
- LAR expressed her concern over the lockers in KK Leung Building. According to LAR, law students thought that lockers in KK Leung Building were very favourable; yet they could never get access to them. LAR thought that the discussions shall be made on how the lockers were allocated; but not just removed.
- UAS1 repeated his desire to benefit all students in general, and would look into the case again.
- UHR hoped that the Report would benefit all students, and reminded that the minority shall not be ignored.
- Besides, P presented the terms of reference of Information Infrastructure and Services Advisory Group (IISAG), and invited Councilors to join the Group.
- DSR presented a new service fee alteration by the University Health Service (UHS), where a 3-tier system was used. He urged Councilors to encourage students to fill in UHS's survey in order to make UHS not raise fee.

- ASR questioned why the photocopying store run by Knowles Production Limited, which owed the Union money, could still operate in the campus. FS placed the responsibility on previous Financial Secretaries for not following up with the issue.

#### 7. To discuss external affairs

- EVP reported to the Council current external events, and apologized for confusion on the arrangements of June Fourth Memorial Activities this year.
- WLHR thought it was not acceptable for HKU students to sit apart in the Victoria Park during the June Fourth Candlelight Vigil, which could not show how united HKU students were towards this issue.
- EVP apologized again and promised to explain to his future successor regarding this issue.
- CAS admitted the on-day situation was underestimated.
- LHHR added that timing was a big problem.
- WLHR mentioned a website which claimed that EVP had sneaked eating during HKFS Hunger Strike.
- EVP admitted the carelessness and ambiguity in his message on the internet. CAS said that the incident could be a lesson for everyone to be careful.
- IVP was shocked about the incident.
- WLHR stressed even if EVP had clarified in Council, the general public would not understand. He could
  accept the act.
- LSKHR made reference to EVP's scandal during running for office, saying he had repeatedly made the same mistake and negatively affected the fame of HKUSU.
- SJCR thought there was a necessity for EVP to respond to the criticism posted on Democracy Wall.
   SKYLHR said that he shall respond on Democracy Wall. WLHR emphasized that EVP needed to be responsible for his acts.
- IVP thought that there was a need for a public statement; and a regret motion could be thought over again.
- SWHR thought that misconduct in speech could not be meditated with only an explanation. LHHR also thought just a verbal apology in Council was not sufficient.
- WLHR emphasized that the repetition of misconduct was not acceptable.
- LCHHR asked if WLHR did not mention the website, whether EVP would mention the site. EVP replied

he would not since he believed it was a political conspiracy. LCHHR disagreed that EVP did not need to respond.

- CAS questioned the seriousness of EVP's misconduct.
- EVP made the analogy of paparazzi and stars having privacy invaded; but ASR thought the analogy was wrong.
- PS questioned the timing of EVP's verbal misconduct, on top of the seriousness of the June Fourth Commemoration.
- EVP made decision to respond to Democracy Wall's criticism and the website.
- CAS urges Councilors to think whether the regret motion would weaken the Union's external image.
- P thought that he had a need to bear responsibility. P had responsibility to lead, and had not done his best.
- DSR thought that Facebook had no longer been private, and EVP shall be careful on these sensitive issues. It shall not only be applicable to the Union Exco, but also to all Councilors.
- AS regarded the regret motion as a negative impact on the Union's image, and hope all Councilors would remedy, for instance, explaining this situation positively to others.
- EVP would release statement regarding his misconducts. He reminded all that being a student leader, one shall not go too much to the forefront, and not too behind.
- WLHR hoped the resolution would not affect cooperation among Councilors, and hoped that everyone could learn from the incident.
- EVP said that everyone shared the burden of ancestors' name, and needed to take every step with care.
- IVP criticized that EVP and CAS were just finding excuses for the incident. He reminded EVP the necessity for humbleness in his apology statement.
- CAS promised that EVP would be cautious in his actions and words. He hoped that all Councilors could think before taking action against a person.
- CC concluded that as a person representing the Union attending a formal activity, EVP had the
  obligation to report the incident to the Council, which was composed of Councilors from different parties
  representing students.
- CC commented P planning regret himself was absolutely inappropriate and not intelligent.

- AS briefly presented the proposed Orientation Regulation 2011.
- P reminded that OAC would have absolute power to amend the Orientation Regulation 2011 if the Regulation would be passed, and urged Councilors to think whether it was appropriate.
- P hoped everyone would cooperate for the orientation activity. Resources gained after fighting over shall

not always be a good thing. He expected that amendments could be made after the Orientation Period 2011 so as to benefit the next session.

- P also urged all parties to pay attention to the promotion details so as not to trigger resentment from Union sub-organizations such as Greenwoods, HKUSU. He wanted attention to be paid on external organizations, where they shall not affect the registration of freshmen.
- AS added that open areas within the University would not welcome uninvited parties doing commercial promotion, and all Union members had the right to ask them to leave.
- AS could not promise that the full list of helpers for Information Day would be available before 20<sup>th</sup> June 2011. A rough one was highly possible.
- AS apologized for not preparing well for OAC meetings, and promised to do better.
- AS warned that there would be twice the number of freshmen next year (i.e. around 6000).
